☐ **Option 1: Travel on Rescheduled Tour in the Fall of 2020 – Full Credit Given** - I/We wish to continue to travel in the fall of 2020 on a rescheduled departure. Nawas will credit the whole value of my tour cost to this departure and Nawas will refund the Passion Play theater ticket (value of \$200 per person). As a substitution for the Passion Play, additional sightseeing will be provided in the Oberammergau area. Land rates are guaranteed.
