49 U.S. Code § 44102. Registration requirements

U.S. Code Notes

- (a) **ELIGIBILITY.**—An <u>aircraft</u> may be registered under <u>section 44103 of</u> this title only when the aircraft is—
 - (1) not registered under the laws of a foreign country and is owned by—
 - (A) a citizen of the United States;
 - **(B)** an individual citizen of a foreign country lawfully admitted for permanent residence in the United States; or
 - **(C)** a corporation not a <u>citizen</u> of the <u>United States</u> when the corporation is organized and doing business under the laws of the <u>United States</u> or a State, and the <u>aircraft</u> is based and primarily used in the <u>United States</u>; or
 - (2) an aircraft of—
 - (A) the United States Government; or
 - **(B)** a State, the District of Columbia, a territory or possession of the <u>United States</u>, or a political subdivision of a State, territory, or possession.

(b) DUTY TO DEFINE CERTAIN TERM.—

In carrying out subsection (a)(1)(C) of this section, the Secretary of Transportation shall define "based and primarily used in the United States".
