Gosh, I hate that they are telling you I said those things. That is just not true at all. Are you getting that information directly from CPS? Or is that coming through Jennifer? Or is that what Jennifer is telling them about the situation in Missouri? They did not get that information from me. I cannot call anyone, but if you sign releases with them they can contact me. Again, there is a reason we reunified the kids with you and not Jennifer. I would be more than happy to discuss those things with CPS or an attorney that contacts me (but you have to sign a release with them). Maybe you should request your Missouri records again so you can have all of that documentation with you? It's been about 9 years since all of that happened, though, so CPS in California will probably look more closely at the current situation than the past situation- just keep that in mind. The past definitely has some important information, but they have to look at the present situation and the information they have right now. Just remember to keep your cool with them. I know you have Izzy's (and the boys') best interest at heart and I cannot imagine how upsetting all of this is after everything you have been through with your kids- I just don't want CPS to miss all of that because I also know how you are when you are upset :) You are a good dad, Eric. I hope this is just a phase for Izzy and that she will quickly figure out how much she really means to you.

Previous to her substance use, she was diagnosed with PTSD, ADHD, and depression with psychosis/psychotic tendencies. Caseworker Jessica Sherrard, during her assessment on the family in 2019, did speak with the family's prior Child Welfare caseworker from Missouri, Amanda Neace who had a wealth of information. Ms. Neace reported that the assessment had been overturned in court and that's the history was destroyed. Ms. Neace reported that the family came to the agencies attention due to David having bruising on his bottom by Eric. It was reported that David was taken to the Advocate Center and they reported that an object had been used on David. Ms. Neace reported that David never did make any disclosures of Eric physically abusing him. Ms. Neace reported that Eric and Jennifer both provided the agency with mental health evaluations. Ms. Neace will be getting back to the caseworker with that information. Ms. Neace reported that when the children were removed from Eric, they were placed with his mother Susan Ranken. Ms. Neace reported that Eric absconded with his children and drove them to California, so they could be with Jennifer. Ms. Neace reported that Eric was criminally charged with this. Ms. Neace reported that the children were put in an in-home plan through an ICPC with Jennifer in California. Ms. Neace reported that Jennifer shortly after had the children removed due to drug use and her significant other sexually abusing Isabel. It was reported that there was no finding due to no disclosures. Ms. Neace reported that Jennifer did move out to Missouri and started programs, but never finished. Ms. Neace reported that Jennifer was very manipulative. Ms. Neace reported that Jennifer ended up leaving with her boyfriend at the time and was never compliant with UA's. Ms. Neace reported that in November of 2010 the children were removed from Eric and right after he took them to California. The children were returned to Eric in January of 2013. Ms. Neace reported that during the period of working with the family, Jennifer had made accusations of domestic violence between her and Eric, but the agency did believe her. Ms. Neace reported that she never thought Eric was going to get his children back due to the rough start at first. This return was considered a success story.<sup>1</sup>
