At this point, we need to have a payment from you so that we can proceed to amend the returns and deal with the balances. I will leave it up to you to contact me to give me an ok to move forward. thank you, Svetlana

I informed them my answer was NO!!

OVATION TAX GROUP: Never proceeded to amend the returns and deal with the balances! NO WORK WAS DONE as stated by Svetlana!

Based on this and the fact I only received 5 emails and 4 text messages for 5,500.00 this was a total SCAM! I already had my taxes redone and owed and paid 20,000 out of the 40,000 originally sent as a deficit on my account.

To eSign the documents first click the ORANGE button above 'REVIEW & SIGN'.

Then when you open the document it might prompt you to put in your last name and dob of birth to authorize you signing. Remember, on the date of birth there are no slashes or dashes. So if your date of birth is 1/1/2020 you would enter 01012020.

Next, when you open the document there should be a black panel on the left with page numbers and Initial and/or Signature with a RED X to the right of each. If you don't see the black panel there will be 3 white lines, or dashes, on the top left of the form. Click those lines then the black panel will appear.

To sign, simply click on the word Initial or Signature and it will bring you to the page needing that Initial or Signature. When it takes you to the appropriate page there will be a RED x (sometimes multiple X's on a particular page). Click on that RED X so a box appears.

Then, using your mouse hold down a left click, sign, and release, then press save. If it's a smart phone or tablet just use your finger.

Repeat these steps until all the RED X's turn to GREEN Checkmarks. Once you've signed everything a GREEN BUTTON 'SUBMIT' will appear below the Red and Blue buttons. Click

SUBMIT and we'll receive the docs immediately and you'll receive a confirmation of the signing as well.






