1. Scope of Work

1.1 **Project Scope**: The Service Provider agrees to develop a web-based application ("Hijacker Alert App") that monitors Amazon listings for unauthorized sellers (hijackers) and provides real-time alerts using the Amazon SP-API. The key features include:

- Monitoring product listings.
- Identifying authorized sellers.
- Comparing active sellers against the authorized list.
- Notifying the brand owner with actionable insights.
- Regular monitoring, updates, and a user dashboard.

1.2 Milestones & Deliverables:

- Milestone 1 (25% Payment): Project initiation and setup. Includes the finalization of design and initial development setup.
- **Milestone 2** (50% Payment): Completion of major features, including core functionalities like Amazon SP-API integration, detection logic, and alert system.
- **Milestone 3** (25% Payment): Final delivery, including all source code, end-to-end testing, and deployment assistance.

1.3 Timelines:

The project is estimated to be completed within 1 month from the commencement date.
 Detailed timelines for each milestone will be agreed upon after the initial design approval.

1.4 Figma Design Approval:

 The final design approved in Figma will act as the single source of truth. Post design approval, no additional changes will be acknowledged unless mutually agreed upon. Any scope additions will be subject to additional charges and timeline adjustments based on feature evaluation.

2. Payment Terms

2.1 Total Project Cost: \$3,500

2.2 Payment Schedule:

- **Upfront Payment (25%)**: \$875 due before starting the development.
- Milestone Payment (50%): \$1,750 due upon completion of the major features.
- **Final Payment (25%)**: \$875 due upon final project delivery, including source code, documentation, and deployment support.

2.3 All payments are non-refundable. Delayed payments may result in project delays.

3. Ownership and Intellectual Property Rights

- 3.1 Upon full payment of the total project cost, all ownership and intellectual property rights for the code, designs, and related deliverables shall be transferred to the Client.
- 3.2 The Service Provider agrees that no part of the work created for this project will be reused, repurposed, or sold to third parties.

4. Confidentiality

4.1 Both parties agree to maintain strict confidentiality regarding any proprietary or sensitive information exchanged during this project. This confidentiality obligation remains in effect indefinitely, even after the project's completion.

5. Revisions and Changes

- 5.1 Revisions to the scope of the project after the Figma design approval will not be acknowledged unless mutually agreed upon. Figma design should act as the single source of truth, and Bubble development would exactly replicate the design approved on Figma.
- 5.2 Any additional changes or features requested beyond the agreed scope will be evaluated separately, and additional charges and timeline extensions will be communicated accordingly.

6. Termination Clause

- 6.1 Either party may terminate this agreement by providing a written notice at least two (2) weeks prior to the desired termination date.
- 6.2 In the event of termination:
 - The Client will pay for any completed work up to the termination date.
 - The Service Provider will deliver all completed deliverables, provided payments have been made in full.

7. Communication

- 7.1 Both parties agree to maintain regular communication throughout the project. The preferred communication methods will be [insert preferred tools like Zoom, Slack, Email].

- 9.2 The Client is responsible for setting up the necessary accounts and infrastructure, including:
