## Formal Statement – Elizabeth Dlouhy

Subject: Harassment, Threats, and Emotional Abuse by Jhonatan Eduardo DelValle

# My Background

My name is Elizabeth Dlouhy, and I currently reside in Dover, Delaware. I am a full-time insurance professional and a probationary volunteer firefighter with the Dover Fire Department. I have no criminal record, no history of misconduct, and maintain full-time employment and community involvement.

#### **Relationship Timeline**

I met Jhonatan Eduardo DelValle in 2019, shortly before Memorial Day. He initiated a romantic relationship under false pretenses, and I later discovered he was married the entire time to a woman named Olga Knureva and had a daughter, Sophia. I was unaware of his marital status during most of the relationship.

During the time we were involved, Jhonatan manipulated me emotionally and financially. He used dishonesty, guilt, and misdirection to maintain control and get money from me. We "broke up" in 2020, and he moved out of state to Virginia. Most of the early relationship and manipulation took place in New York, but the more serious threats and harassment occurred while I was living in Delaware.

# Ongoing Pattern of Harassment and Threats

Since 2020, Jhonatan has repeatedly resurfaced to harass me. He contacts me after long periods of silence and becomes emotionally unstable when I do not respond the way he wants. His messages consistently follow this pattern:

- Unsolicited attempts to reinsert himself into my life
- Emotional manipulation and blame-shifting
- Guilt trips and martyr-like statements
- Vague or direct threats

- References to self-harm if ignored
- Attempts to weaponize false narratives about my character
- Using his daughter as emotional leverage
- Complete lack of accountability for past actions

These cycles happened repeatedly in 2020, 2023, and again in July 2025. In 2025, I replied once with a single message setting clear boundaries. That one message triggered a barrage of hostile responses including:

- Baseless accusations
- Disturbing suicide references
- Attempts to shame me for cutting contact
- Empty threats and personal attacks

I have never threatened or provoked him. My messages have been calm and limited. This is not about a one-time argument—it's about a documented pattern of instability, emotional abuse, and veiled threats, occurring over years.

### **Employment and Property Misrepresentation**

Jhonatan claims to be employed by Amazon. I cannot verify whether this is true, but I believe this behavior warrants internal review if he is affiliated with the company.

He also claims to have purchased a home in Virginia Beach, but a search of property records has not confirmed any ownership in his or his wife's name. The last confirmed address was a rental property at 1945 Stillwood Lane, and he may now be living at 5909 Woodstock Ct. However, no property records show ownership under his name, consistent with his ongoing misrepresentation of his financial status and identity.

## **Current Status and Safety Concerns**

I have not seen him in person in years. I have not contacted him voluntarily. He initiated contact in 2023 and again in 2025 without provocation. I responded once in July 2025 to

shut it down—and the flood of abusive responses that followed confirms the risk of continued contact.

I do not feel safe with his continued ability to reach me. His unhinged messages escalate quickly and mirror past incidents. He has made vague threats and referenced suicide in a manipulative context—behavior that is emotionally abusive, dangerous, and deeply inappropriate.
