However, the officers did allege that I failed one question namely: "Do you know the identity of the alleged accomplice of Dustin Wehde." Or words to that effect, this question is invalid due to the fact that there was no second person in the house.
2. Richard O'brien Chicago IL. Repeated Iowa DCI exam. Inconclusive results due to anxiety, he suggested retaking exam.
3. March 06 2004 Mike Hanna Omaha NE. Repeated DCI Exam. Passes with high level of confidence (2% possibility of deception). MIKE TOLD 20mg of Valium before the exam.
