RULING ON PETITIONER'S MOTION
TO EXTEND PROTECTIVE ORDER
WITH REGARD TO FIREARMS

On October 30, 2006, hearing was held on Petitioner's motion to extend the protective order with regard to firearms. The Petitioner Tracey Richter Roberts appeared with her attorney Phil Redenbaugh. The Respondent Michael Ross Roberts appeared by telephone per se. The hearing was held on the record. At the conclusion of the hearing, the Court took the matter under advisement.

The Court, after reviewing the court file and considering the evidence, now finds and rules as follows:

On May 3, 2004, the Court (Honorable Don E. Courtney), following an evidentiary hearing, entered the following order:

"It is further ordered that the Respondent shall deliver all firearms in his possession to the custody of the Buena Vista Sheriff's Department while this matter is pending."

The Respondent is apparently under the impression that the restriction on firearms has been lifted. However, a review of the court file indicates that the prohibition against possession of firearms by the Respondent is still in effect. This action is still pending.

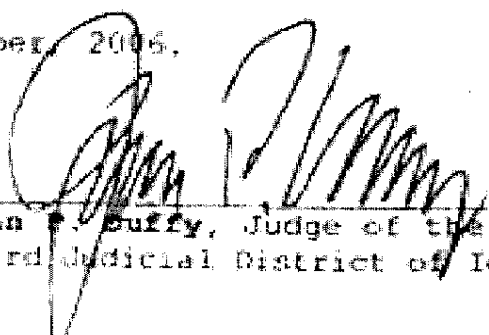
The Respondent contends that he needs to have possession of firearms for his own protection. He contends that the Petitioner has made threats to kill him. This assertion is unsupported by the evidence.

IT IS THEREFORE ORDERED that the Respondent Michael Ross Roberts is prohibited from having possession of firearms and dangerous weapons.

The Respondent Michael Ross Roberts shall deliver all firearms and dangerous weapons in his possession to the Buena Vista County Sheriff's Department.

The Clerk of Court shall mail or deliver a copy of this order to Phil Redenbaugh, attorney for the Petitioner, and shall provide a copy of this order to the Respondent by mailing a copy of this order to the Respondent at his last known mailing address.
