RAYMOND STATES HE IS THE VICE PRESIDENT OF STRATIGIC PARTNERSHIPS FOR XELLEX CORPORATION. THIS IS ON THE SALES AND MARKETING SIDE. PREVIOUSLY HE HAD WORKED FOR I-TECH IN WASHINGTON, DC.

I ASKED RAYMOND WHERE HE WAS ON THURSDAY 12-13-2001. HE SAID HE AND MICHAEL WERE ON A SALED TRIP TO DENVER AND MINNEAPOLIS. HE SAID THEY DROVE TO MINNEAPOLIS ON TUESDAY EVENING AFTER A PRAYER MEETING. HE SAID THEY LEFT HIS RESIDENCE ABOUT 2200 ON 12-12-2001. HE SAID THEY DROVE TO MINNEAPOLIS AND SPENT THE NIGHT. RAYMOND SAID THEY DROVE HIS 1999 HONDA ACCORD.

RAYMOND SAID THEY FLEW FROM MINNEAPOLIS TO DENVER ON WEDNESDAY MORNING. HE SAID THE FLIGHT LEFT AT 0915 OUR TIME. HE SAID THEY MET WITH IQ DESTINATIONS IN DENVER. ON THURSDAY MORNING THEY FLEW BACK TO MINNEAPOLIS ARRIVING ABOUT 1215 OUR TIME.

RAYMOND SAID THEY MET WITH A BENCH MARK SALES REPRESENTATIVE. HE SAID THEY FINISHED THE MEETING AT ABOUT 1700. HE SAID THEY THEN MET WITH A RECENTLY HIRED FULL TIME EMPLOYEE OF XELLEX. HE SAID THEY HAD SUPPER WITH HIM. THE EMPLOYEE IS KENNETH MAYER. HIS HOME PBX IS 208-283-1480.

RAYMOND PROVIED ME WITH COPIES OF BUSINESS CARD OF THE PEOPLE THEY MET WITH ON WEDNESDAY AND THURSDAY. THAT INFORMATION IS ATTACHED TO THIS INTERVIEW.

I ASKED RAYMOND IF KIRK GOETTSCH WORKED FOR XELLEX. HE SAID HE DID FOR A TIME. HE SAID KIRK WAS THE BUSINESS OPERATOR. AFTER KIRK LEFT NO ONE IS DOING HIS WORK. RAMOND SAID THEY WERE IN THE PROCESS OF HIRING AN ACCOUNTANT.

I ASKED RAYMOND IF HE KNEW OF ANY CURRENT FINANCIAL PROBLEMS FOR XELLEX. HE SAID THERE IS SOME CURRENT CASH FLOW DIFFICULTIES BUT NOTHING SERIOUS.

NEXT I ASKE RAYMOND IF HE KNEW DUSTIN WEHDE. HE SAID HE DID. HE SAID WHEN HE FIRST MET DUSTIN HE HAD A BAD FEELING ABOUT HIM. HE SAID HE TOLD MICHAEL THAT THERE WAS SOMETHING WRONG WITH HIM.

I ASKED RAYMOND IF DUSTIN EVER HAD ANY FRIENDS THAT HE KNEW OF. HE SAID HE ONLY HEARD OF ONE FRIEND AND HIS MOTHER. DIDN'T LIKE HIM. RAYMOND SAID HE DIDN'T KNOW THE GUY'S NAME.

I ASKED RAYMOND WHERE THEY WERE WHEN THEY GOT THE CALL ON THE SHOOTING. HE SAID THEY IN MINNEAPOLIS. I ASKED HIM WHAT HE AND MICHAEL TALKED ABOUT ON THE WAY HOME. HE SAID RIGHT AFTER THE CALL, THEY BOTH WONDERED IF IT WAS SOMEONE LOCAL AND IF IT WAS WHETHER IT WOULD BE DUSTIN. X X
